If health care insurance or a third party payor is being used, by signing below, I also agree to have Dr. Willis, and his staff, submit claims to my insurance companies for reimbursement of services provided. I acknowledge I, and not my insurance company, am responsible for full payment of all fees incurred. Payments can be made directly to Dr. Willis.

I understand and agree Dr. Willis may use and disclose health information about me. I understand my health information may include information both created and received by Dr. Willis, may be in the form of written or electronic records or spoken words, and may include information about my health history, health status, symptoms, examinations, test results, diagnoses, treatments, procedures, prescriptions, and similar types of health-related information.
